

**CITY OF GALLUP  
UTILITY RATES  
JULY 01, 2006**

**ELECTRIC RATES**

Monthly bills include two basic components energy charge (kWh) and Demand (kW) for large commercial customers. The charges for all electricity consumed shall be at the following rates:

(A) Residential Service rate shall apply to electric service to single-family dwelling, where the major use of electricity is for domestic purposes such as lighting, household appliances, and the personal comfort and convenience of those residing therein.

**Energy Charge:**

First 50 kWh:	Included in Minimum Service Charge of \$5.77
Thereafter all kWh:	\$0.0872 kWh

(B) General Service-Small (Non-residential) rate is available for single and three-phase service for non-residential service. This rate applies to customers whose consumption is less than 40,000kWh per month or a demand less than 100kW.

If demand is over 100kW per month for three consecutive months within a twelve month period or consumption is equal to or greater than 40,000kWh will not be provided service under this rate.

**Energy Charge:**

First 100 kWh:	Included in Minimum Service Charge of \$11.55
Thereafter all kWh:	\$0.0937 per kWh

(C) General Service-Medium (Non-residential) rate is available for single and three-phase service to customers whose consumption is greater than or equal to 40,000 kWh or 100 kW per month for three consecutive months within a twelve month period.

Demand charge is the sum to be paid by large electric consumers for their peak usage level for which GJU recovers the cost of providing facilities to accommodate the peak demand.

(D) Municipal Service General rate: Municipal service general rate is available to municipal buildings and some streetlight consumption:

(E) Municipal Service Joint Utilities Rate: Municipal service joint utilities rate is available to joint utilities including water department, wastewater department and electric department:

**Energy Charge:**

All kWh at:	\$0.0819 per kWh

(F) Outdoor Area Lighting: Effective on or after July 1, 2004, the following provisions shall apply to the rental rates for outdoor High pressure Sodium Vapor lights installed on existing city poles:

**A monthly charge of:**

150 Watt	\$ 5.76
250 Watt	\$ 13.18
400 Watt	\$ 16.46

(G) Metered Street and Highway Lighting Rate:

**Energy Charge:**

All kWh at:	\$0.0819 per kWh

**WATER RATES**

A monthly service charge of \$7.48 is assessed to all consumers with one meter per dwelling. However, when one meter services more than one dwelling or the meter is larger than two inches (2") in size. The following monthly service charges will apply:

4,001 to 100,000 cubic feet	0.039975 per cubic foot
Over 100,000 cubic feet	0.040015 per cubic foot

(C) Separate Irrigation Meter Charge:

All usage	0.056803 per cubic foot

(D) Service to the City of Gallup, a monthly commodity charge of \$0.037962 per cubic foot.

(E) Unmetered Water Sales Charge:

All usage	0.065422 per cubic foot (Equivalent to \$8.75 per 1,000 gallons)

(F) Sub Metered Multi-Family Dwellings and Mobile Home Parks having private sub meters on each individual dwelling shall be at the commercial rate of \$0.032712 per cubic foot.

(G) For service outside the city limits the water rate shall be at one and one-half the rate for service inside the city limits.

**WASTEWATER RATES**

A monthly service charge is assessed to all consumers' based on water meter size:

(A) Residential rate is applicable to one water meter per residence no larger than two inches (2").

(C) Commercial Volume Charge:

All usage	0.024130 per cubic foot (Based on water consumption)

(D) The wastewater rate for residents that do not have City water service a maximum of 2,000 cubic feet per month will be charged, with applicable service charges.

(E) The wastewater rate for commercial accounts that do not have City water will be based on the previous year's average commercial usage.

(F) For service outside the city limits, the wastewater rate shall be twice that for service inside the city limits.

(G) The wastewater rate for residential and commercial accounts not having City water service but which have a metered water service shall be based on water usage and be billed at the applicable rate.

(H) Reclaimed Wastewater Charge:  
 All usage 0.012306 per cubic foot  
 (Equivalent to \$1.65 per 1,000 gallons)

(I) Septic Treatment Charge:  
 All usage 0.270736 per cubic foot  
 (Equivalent to \$36.23 per 1,000 gallons)
