MEMORANDUM OF AGREEMENT

The MOA is a comprehensive agreement between the City of Gallup and the County of McKinley. This agreement becomes effective upon signature of the last signing party.

The parties agree as follows:

To file an application through the Edward Byrne Memorial Justice Assistance Grant (JAG) Program for 2019. This agreement is solely for the split of the grant funds available. The grant amount is \$29,303. The agreed amounts: \$20,512 will go to the City of Gallup Police Department and will be used for the purchase of a K-9 and training. The remaining amount of \$8,791 will go to the McKinley County Sheriff's Office to be used for advanced training for law enforcement, to include K-9 training, E.R.T./S.W.A.T. training, and other advanced law enforcement training, along with all related training expenses. 3% of the McKinley County Sheriff's Office allotment will be spent on N.I.B.R.S. compliance activities, per the grant.

The City of Gallup agrees to be fiscal agent to apply for the grant funds and the County of McKinley agrees to the arrangement.


The City of Gallup will administer this grant and will be responsible for any fiscal agent responsibilities, to include monthly, quarterly, and yearly reports including financial narrative reporting. All reporting will be handled through the City of Gallup Finance Department.

Gallup Police Department and McKinley County Sheriff's Office will get reimbursed by City of Gallup after they have expended the funds and provided the proper documentation per grant requirement. This reimbursement will take place within 30 days of providing such. City of Gallup will then get reimbursed by the Department of Justice.

There is no requirement for matching of funds for this program funding.
