**Resolution No. 2022-43**

**A RESOLUTION DECLARING THE ELIGIBILITY AND INTENT OF THE CITY OF GALLUP TO SUBMIT AN APPLICATION TO THE NEW MEXICO DEPARTMENT OF TRANSPORTATION (NMDOT) FOR FISCAL YEARS 2023/2024 NMDOT Special I-10 & I-40 Planning Funds .**

**WHEREAS**, the City of Gallup, New Mexico, has the legal authority to apply for, receive, and administer state funds;

**WHEREAS**, the City of Gallup, supports the NMDOT's role as the State Transportation Department and owner of I-10 & I-40 and their role to receive and administer NMDOT Special I-10 & I-40 Planning Funds; and,

**WHEREAS**, the City of Gallup is submitting an application for the Fiscal Years 2023/2024 (FY 23/24) New Mexico Department of Transportation funds in the amount of \$4,000,000.00; and,

**WHEREAS**, the (I-40 & NM118 East & West Gallup Interchanges Phases 1A, 1B, 1C) project named in the NMDOT Special I-10 & I-40 Planning Funds application is an eligible project under New Mexico NMDOT Special I-10 & I-40 Planning Funds requirements; and,

**WHEREAS**, the City of Gallup acknowledges that the NMDOT Special I-10 & I-40 Planning Funds requires no local match (0%); and,

**NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF GALLUP, NM THAT:**

1. The City of Gallup authorizes Clyde "C.B." Strain to submit an application for FY 23/24 New Mexico NMDOT Special I-10 & I-40 Planning Funds in the amount of \$4,000,000.00 from the New Mexico Department of Transportation (NMDOT) on behalf of City of Gallup.
2. Clyde "C.B." Strain is also authorized to submit additional information as may be required and act as the official representative of the City of Gallup in this and subsequent related activities.
3. That the City of Gallup authorizes the NMDOT to receive and administer the NMDOT Special I-10 & I-40 Planning Funds for the (I-40 & NM118 East & West Gallup Interchanges Phases 1A, 1B, 1C) using these funds as set
