Elbows needs to fit a diameter of 0.875" cable and to include all adapter fittings to be used on PME9 & 600A/200A combo sectionalizing cabinet.

Response:

15kv 3phase Sectionalizing Cabinet 4way 600A/200A Combo; accommodates 200A taps off of the 600A
