



**March 3, 2020 Municipal Officer Election  
 First Disclosure of Campaign Financing  
 Due Tuesday, February 18, 2020 at 12:00 p.m.**

Pursuant to the Gallup Municipal Code (Sections 1-10A-4C(1-3)) candidates who either receives contributions or expends funds in an amount that exceeds \$1,000 shall file their first statement, signed under oath, with the City Clerk. The first statement is due on the Tuesday two (2) weeks preceding the election no later than 12:00 noon. The name and address of each contributor must be disclosed when the total cumulative cash value contributed by the contributor exceeds \$100.00. All expenditures made on behalf of the campaign, including any reimbursements and the nature thereof, must be disclosed with the name and address of the person or business to which payment was made. The City Code also requires the City Clerk to create an electronic data base for all campaign reporting and to place the information on the City's website. The candidates are listed in the database according to ballot order.
