- 4) **CLARIFICATION:** Per Conditions of Contract, page 13 of original solicitation is as follows. Salvageable, demolished materials to include excavation spoils will therefore be disposed as follows:

SALVAGEABLE MATERIAL: ALL MATERIAL DEEMED SALVAGEABLE FROM EXISTING OWNER FACILITIES WHICH ARE TO BE ABANDONED SHALL REMAIN THE PROPERTY OF THE OWNER. SALVAGEABLE MATERIALS SHALL BE DELIVERED TO THE CITY OF GALLUP ELECTRIC DEPARTMENT, 1890 WAREHOUSE LANE, GALLUP NM. MATERIAL DEEMED NOT SALVAGEABLE SHALL BE THE CONTRACTOR'S PROPERTY AND SHALL BE DISPOSED OF IN ACCORDANCE WITH LOCAL, STATE AND FEDERAL RULES, REGULATIONS AND LAWS.
- 5) **CORRECTION:** On project drawings, Electrical Section, page E-6 on Section 1, correction shall be corrected as follows:
13.2KV-480/277V, 3P Padmounted Transformer XFMR-2 to be provided by Contractor.
- 6) **CORRECTION:** On Proposal Form for Contract, page 88, the project title shall be corrected to read:
INDIAN HILLS PARK ELECTRICAL AND LIGHTING SYSTEM IMPROVEMENTS

- 7) **REVISION:** On Bid Form, page 92-93 of the original bid solicitation, the Bid Schedule (Cost Proposal) shall be revised per attached; please use when submitting a bid. Please also note that a correction to the liquidated damages in undersigned paragraph shall be corrected to **\$100** per day for each calendar day and NOT \$1000.
